### STUDENT PARKING

*Student parking is a PRIVILEGE, not a right. Students who abuse parking lot rules will have their vehicles towed and their parking privilege revoked. The rules are as follows:*

1. Parking permits are required to park in the student parking area. Students are not allowed to park in the faculty lot.
2. The only reason for a student to be in a vehicle is to arrive and depart from school. Students may not return to their car during the day to retrieve "forgotten items."
3. Loitering in the parking lot at any time is strictly prohibited (6:40-5:00).
4. Vehicles should remain locked at all times while at school.
5. Cars are off limits during the day unless special permission is obtained from one of the assistant principals or released from the attendance office with a pass.
6. Vehicles must be driven in a safe manner; the speed limit is 5 mph in school lots.
7. Students must follow the directions of campus supervisors routing traffic in the parking lots.

## Senior Parking Addendum:

  - An off campus pass
  - An internship
  - Work Experience (the period directly following lunch)
  - Free 6th period (Wednesdays only)
  - Free 7th period (Thursdays only)

“For the first twelve months a teen holds a license, he or she cannot transport other teenagers under 20 years old, unless accompanied by an adult (licensed driver 25 or older).”

“For the first twelve months, a teen may not drive between 11 p.m. and 5 a.m., unless accompanied by an adult. “
